During routine operations at the Kerr 14C-25HZ well, a flowline failure was discovered. Approximately 15 barrels of oil were released. Excavation and cleanup activities are ongoing at the site. Confirmation soil samples will be collected from the excavation and will be submitted for laboratory analysis of TPH, BTEX, pH, EC, and SAR (if applicable). The analytical results and excavation details will be provided in a supplemental report. A topographic Site Location Map showing the general location of the release is attached as Figure 1.
