#### COMMENTS:

The well will be drilled to a KOP at 5450' TVD. A curve will be built to landed in the Niobrara at 5971' TVD. The lateral will be drilled with a 7-7/8" bit to TD at 14036 MD. A 5-1/2" casing string will be run with a marker joint to isolate the legal productive interval and cemented to surface. If hole issues occur during the drilling operation we will revert to the outlined contingency drilling program.
