Comments:

All disturbed during drilling operations areas were graded back to near original conditions. The seed bed was prepared by ripping, disking, and chisel plowing the topsoil. A seed drill was used to plant Sharp's dry land pasture mix at 25 lbs. per acre. Weed-free straw was then crimped into the soil at 4,000 lbs. per acre. The grasses have established and are at least 80% vegetation density compared to pre-disturbance conditions.

This was an old site that was reoccupied to drill new wells.
