<p>This sundry is being submitted to change the cementing/ casing design of this well to a monobore. An oil-based system will additionally be used for the 7 7/8" hole. A sundry for the Johnsons Corner location (ID# 440793) has been submitted for the WMP to reflect this shift from a purely water based system. An offsite commercial disposal plan is already in place.</p> <p>Our cementing/ casing plan does provide coverage for the Upper Pierre Aquifer as the long string of this well will be cased to surface and cemented up into the surface casing.</p> <p>The PWP of this well is the same as the originally permitted well.</p>
