**COMMENTS:**

The well will be drilled to a KOP at 5300' TVD. A curve will be built to landed in the Niobrara at 5821' TVD. The lateral will be drilled with a 8-1/2" bit to TD at 13432 MD. A 5-1/2" casing string will be run with a marker joint to isolate the legal productive interval and cemented to surface. If hole issues occur during the drilling operation we will revert to the outlined contingency casing program.
