## COMMENTS:

Noble Energy, Inc. respectfully requests to change the casing plans for the subject well to create a monobore. The following items will not change: bottom hole location, surface hole location, top of producing zone, the nearest well and Spacing Unit configuration. Noble plans to deepen the surface casing to a depth of 1850' in order to ensure coverage of the base of the Pierre Aquifer for oil base mud considerations. Surface casing will be cemented with a lead of 450 sacks of 13.5 ppg 1.74 cu ft/sk Varicem and a tail of 75 sacks of 14.2 ppg 1.53 cu ft/sk Varicem cement. No intermediate casing will be run. The production string will be as follows:  
Hole size will be 8-1/2"  
5-1/2" 20# P-110IC BTC casing from total depth to surface  
550 sacks of 13.6ppg 1.88ft3/sk. DV Tool set at 80°.  
Oil Based Mud will be planned for the production hole interval only.
