#### COMMENTS:

Noble Energy Inc. respectfully requests to change the casing plans for this well to create a monobore. The BHL, SHL, Top of Producing Zone, and Spacing Unit will not change. Noble will deepen surface casing to 1,850'. This will cover the base of the Pierre Aquifer for OBM considerations. Surface cement will be 450 sks 13.5 ppg lead and 60 sks 14.2 ppg tail. No intermediate casing will be ran. The production string will be:

- Hole size will be 8-1/2"
- 5-1/2" 20# P-110IC BTC casing from TD to surface.
- 645 sks 13.2 ppg lead, 635 sks 13.5 ppg tail. DV Tool set at 80 deg.

Oil Based Mud will be planned for the production hole interval only.
