OPERATOR COMMENTS AND SUBMITTAL

Comments

- 1) Explanation of situation: There was a downhole tool failure resulting in approximately 90' of BHA remaining at the bottom of the well. We have conducted two fishing runs without success are planning to proceed with the sidetrack. At the time of failure we had just completed the curve and drilled about 200' into the lateral.
- 2) Total measured depth of wellbore being sidetracked: 7132'
- 3) Casing set: Conductor – 16", A252A, 42#/ft set at 104'; Surface – 9.625", J-55, 36#/ft set at 1970'
- 4) Description of fish in hole: The driveshaft of the motor snapped leaving the bit, rotary steerable assembly, MWD and the bottom half of the motor downhole. The bottom of the fish is at TD of 7132' MD with the top at 7043' MD.
- 5) Description of proposed plugs: N/A; We will conduct an openhole kick-off
- 6) Type of cement to be used: N/A
- 7) Measured depth of proposed sidetrack KOP: 6,950'
- 8) Proposed objective formations for sidetrack hole: Niobrara C (Unchanged from previous permit)
- 9) BHL target for sidetrack hole: Same as previous wellbore
