Chris et. al.,

This e-mail is to summarize the initial conversations held yesterday with Chris Canfield (COGCC) and Patrick Murphy (Boulder County) and efforts yesterday and subsequent conversation today with Mindy Carson-Hatcher (Landowner- Boulder County Open Space) regarding a spill/flowline leak that was identified at the Brereton 1-14, 8J location located at NWSE, Sec. 14, T1S, R69W. Reference COGCC facility ID is 321416 and the operator is 8 North. 8 North will be meeting onsite today with County Representatives.

Yesterday afternoon work began to identify the issue that was visually identified, and during that effort contaminated soil was encountered. The roustabout crew then excavated around the flowline, and got to a stopping point so as to provide enough information to notify said parties. We believe there is more excavation that will be needed and I will engage Tasman Geo-Sciences to aid in determining and verifying the extent. No groundwater has been encountered at this time.

We will be submitting an initial form 19 in the next couple of days with follow up efforts.

Mr. Maclaren has been cc'd as a matter of inclusion due to flowline leak identification.
