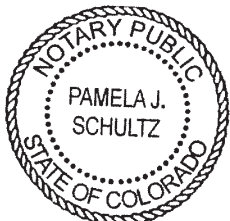

PUBLIC NOTICE
OF
PROPOSED UNDERGROUND INJECTION CON-
TROL PERMIT

PURPOSE OF PUBLIC NOTICE:

The purpose of this notice is to solicit public comment on the SG 924-29D disposal well, a Class II injection permit submitted by WPX Energy Rocky Mountain LLC. The SG 924-29D disposal well has a planned drilling location 1,066 feet from north line and 1,983 feet from east line NWNE Section 32, Township 7 South, Range 96 West, 6th P.M., Garfield County, Colorado.

BACKGROUND

Class II injection wells are permitted and regulated in such a manner as to prevent the contamination of underground sources of drinking water and to ensure fluid emplacement and confinement within the permitted injection zones. Class II injection wells are permitted to inject waste generated from oil and gas exploratory and production operations. WPX Energy Rocky Mountain LLC. has proposed to inject these fluids into the (top down) Rollins (5,584-5,684 ft and Cozzette/Corcoran (5,840-6,107 ft.) Members of the Iles Formation in the SG 924-29D well.

Public comments are encouraged and will be accepted, in writing at the Commission for a period of thirty (30) days after publication of this notice. If any data, information, or arguments submitted during the public comment period appear to raise substantial questions concerning proposed injection well permit, the Director may request that the Commission hold a hearing on the matter.

Additional information on the operation of the proposed injection well may be obtained at the Commission office.
