COMMENTS:

This location has been a receiving site for produced water transferred from OXY to Piceance Energy (now referred to as Laramie Energy, LLC) from various OXY locations within the Plateau Valley for completion operations being conducted by Laramie. The water was transported by water truck from OXY produced water tanks on location via CR330 east to Harrison Creek, then south on Harrison Creek road to one of 2 COGCC approved temporary completion support locations. With the recent purchase/acquisition of the OXY assets the water sharing agreement between these parties is no longer applicable. Subsequent to this submittal the yearly water transfer analysis and report(s) will no longer be provided to the COGCC. This submittal is intended to accommodate the annual (and final) reporting requirements. Attached to this submittal is the required water quality analysis. A total of 776 water transfers, totalling 64,373 barrels of produced water, were completed by water truck between tank batteries associated with the two companies, between 5/12/2015 and 2/8/2016. All water transferred was recycled for use during Laramie Energy well completion activities.
