### WARNING LETTER #2559976

**This Warning Letter is to inform you that the oil and gas facility or the oil and gas operations listed above may be in violation of the rules and regulations of the Colorado Oil and Gas Conservation Commission (“COGCC”) and correction action is required.**

There is reasonable cause to believe that one or more violations of the Oil and Gas Conservation Act, or of a rule, regulation, or order of the Commission, or of a permit issued by the Commission, has occurred. The Operator’s compliance with this Warning Letter is required to resolve the alleged violation(s). This document requires the Operator to timely respond to the COGCC and to comply with directives as listed by the **Corrective Action Deadline Date**. Failure to do so will result in the issuance of a Notice of Alleged Violation and initiation of enforcement proceedings in which COGCC will seek monetary penalties for the alleged violations pursuant to § 34-60-121, C.R.S. and Rule 523, COGCC Rules of Practice and Procedure, 2 CCR 404-1.

The COGCC requires Joseph J.C. Paine dba Paine Petroleum Company LLC to implement corrective action(s) for the conditions identified below.

The COGCC has recently attempted to contact Joseph J.C. Paine dba Paine Petroleum Company LLC by phone and mail without success. COGCC records indicate that Steve Young with Petroleum Field Services as the “Principal Agent” designated to accept and receive notices from the COGCC.

The Colorado Secretary of State records indicate Brian Boggard Qualls is the registered agent for Paine Petroleum Company LLC, and that a change of address was filed 7/24/2014.

COGCC records indicate that Joseph J.C. Paine dba Paine Petroleum Company LLC is operating the Anadarko #1 well in Adams County.

Therefore, COGCC is requesting that a Form 1 Registration for Oil and Gas Operation (change of information) be filed per Rule 302.a. The Form 1 shall provide current address, contacts and an alternative emergency contact and emergency phone number.

If the attached Form 1A Designation of Agent (principle agent and designated agents) are not correct, a Form 1A shall be submitted deleting these agents. A new Form 1A shall be submitted designating a new “principal agent” to accept and be served with notices from the COGCC pursuant to Rule 302.b.

- 3) Complete and submit a Form 1A designating a new "principal agent" serving as the representative of the operator to accept and be served with notices from COGCC. The Form 1A may list employees/ individuals "designated agents" of this company authorized to sign and submit documents on behalf of the operator. This form shall provide valid direct phone numbers, valid email address, and signatures for all parties listed, and signature approval from an officer or principal of the registered operator/company.

**Corrective Action Deadline Date: April 4, 2016**

**Failure to Comply with Warning Letter:**

If Joseph J.C. Paine dba Paine Petroleum Company LLC fails to perform required corrective actions, COGCC will issue a Notice of Alleged Violation and seek penalties pursuant to § 34-60-121, C.R.S. and Rule 523, COGCC Rules of Practice and Procedure, 2 CCR 404-1. (Please note that the COGCC's penalty authority was recently increased to a maximum of \$15,000 per day and penalties are no longer capped at a maximum of \$10,000 per violation.)
