Please find the enclosed Warning Letters for **PAINE* JOSEPH J.C. DBA PAINE PETROLEUM COMPANY LLC's** (Paine's) facility in Adams County, Colorado. COGCC previously issued Warning Letter #2193210 on December 14, 2015, but that letter was returned undeliverable. Unless the well has been producing, Warning Letter #2193210 requires the following:

Your options for returning the well to compliance are to: pass an MIT, or plug and abandon the well. To comply with Rules 316B/319/326: submit a COGCC Form 42 followed by a Form 21; or file a Form 6 - Well Abandonment Report as a Notice of Intent to Abandon for approval prior to performing the work and a second Form 6 - Well Abandonment Report as a Subsequent Report of Abandonment upon completion. Corrective Action Deadline Date: April 30, 2016

If needed, you must submit any past due Form 4(s), Form 5A(s), and/or Form 7(s) within thirty (30) days of the date of this letter.



As 30 days from the December 14, 2015 issuance of Warning Letter #2193210 lapsed on January 13, 2016, the new deadline to submit past due Form 4(s), Form 5A(s), and/or Form 7(s) for JOSEPH J.C. PAINE #NO. 1 ANADARKO (API 001-09718) is April 4, 2016. The last monthly Form 7 reporting for this well on record with COGCC was in March 2012, so there are definitely delinquent Form 7's in this case.

Instructions for Paine to respond and complete corrective actions for the other Warning Letters are included in the Warning Letter documents.
