COMMENTS:

Wiedeman 29-1 well experienced a bradenhead pressure incident 11/14 during stimulation operations on the PDC Wiedeman 29K-403. At the 29-1 the first alarm, set at 200 psi, occurred at 11:52 PM and operations at the 29K-402 were shut down. A tank was rigged to the 29-1 and bradenhead pressure bled-off to that tank.
The 29-1 was prepared for the 29K-403 stimulation operations in compliance with COGCC mitigation requirements. Accordingly, a RBP was set in 4 ½" casing @ 6924' (43' above top of Niobrara), casing was successfully pressure tested to 2000 psi and a 5K wellhead installed.
