Extraction Oil & Gas is planning to drill the following 12 horizontal wells as follows:

Seltzer 1: 233' FNL, 2372' FEL ; Seltzer 7: 233' FNL, 2222' FEL ;
Seltzer 2: 233' FNL, 2347' FEL ; Seltzer 8: 233' FNL, 2197' FEL ;
Seltzer 3: 233' FNL, 2310' FEL ; Seltzer 9: 233' FNL, 2172' FEL ;
Seltzer 4: 233' FNL, 2297' FEL ; Seltzer 10: 233' FNL, 2147' FEL ;
Seltzer 5: 233' FNL, 2272' FEL ; Seltzer 11: 233' FNL, 2122' FEL ;
Seltzer 6: 233' FNL, 2247' FEL ; Seltzer 12: 233' FNL, 2097' FEL

The surface locations of Extraction's proposed wells have been staked outside of the COGCC Greater Wattenberg Area (GWA) Drilling Window as required by Rule 318.A.a. In addition, under the COGCC Rule 318A.c. any new well is to be located within 50 feet of an existing well. Extraction's proposed wells are located greater than fifty feet from the nearest Oil & Gas well. Extraction Oil & Gas respectfully requests that you, as surface owner, waive Rules 318A.a. & 318A.c. in the attached waiver in order to drill the referenced wells above.
