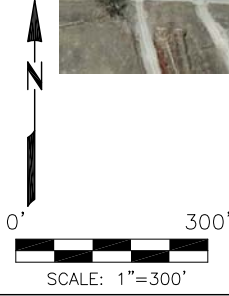
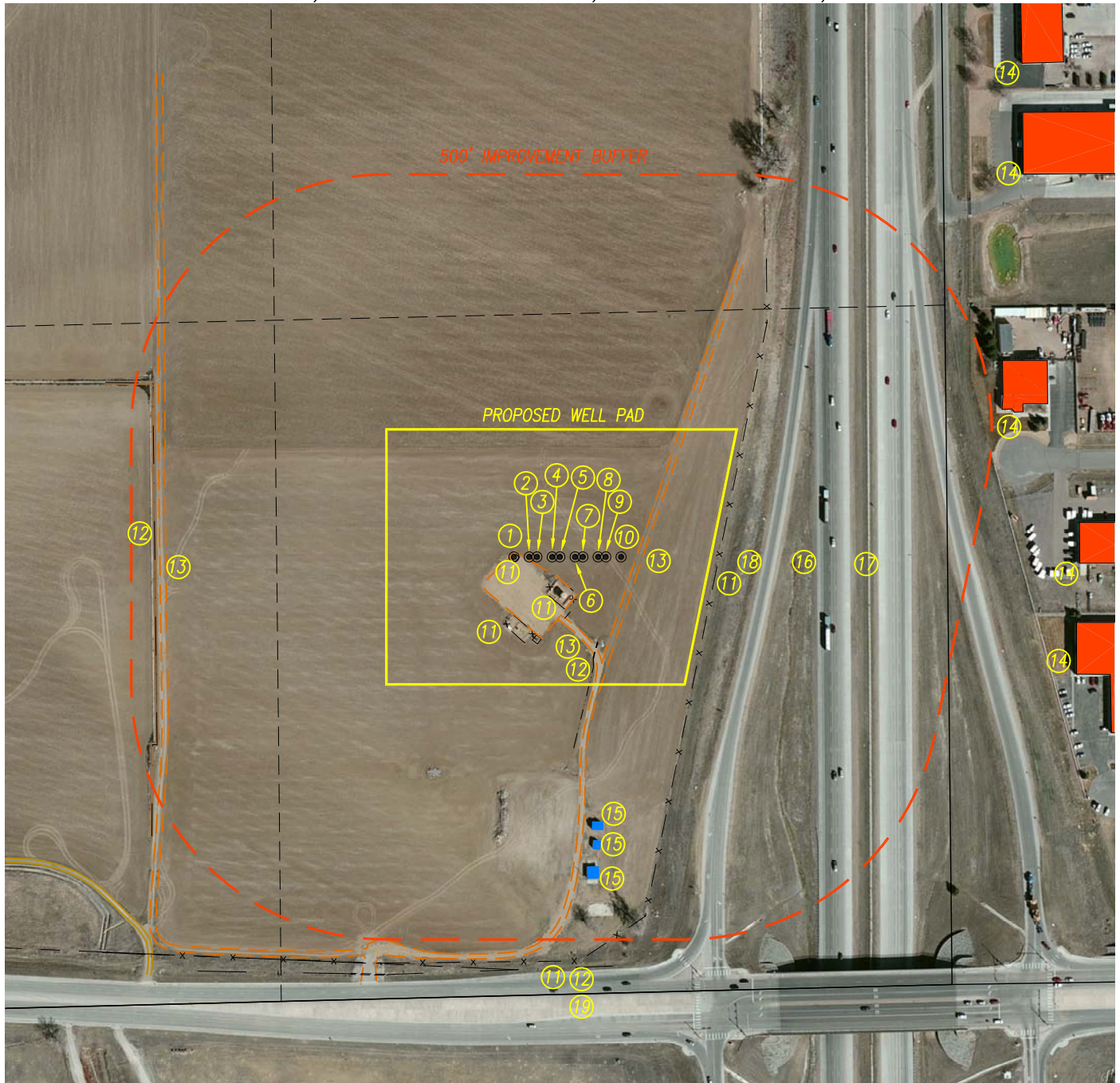


**LOCATION DRAWING: HILGERS 40N-34HZ PAD**
