This COGCC Form 4 is being submitted in order to permit the re-use of treated E&P material that is currently stored at the GM 11-2 (COGCC Facility #334771, Spill tracking #400952552). The treated E&P material was generated during spill remediation activities. With the COGCC's approval, approximately 40 yards of treated material would be transported to the GM 21-2 well pad and used as a backfill material on another remediation project (COGCC Facility #311584, Remediation #7714). WPX already received the landowner's approval to proceed with the transportation and re-use of the treated E&P waste. The laboratory results for the treated E&P waste are summarized in the attached table. The analytical laboratory reports are included as an attachment.
