This sundry is being submitted per requirement of Notice to Operators - Procedures for Setting Conductor Pipe as the well will not be drilled within 30 days of conductor pipe being set. The B&V Pad (Loc ID 440634) has been constructed and is scheduled for drilling operations beginning in August 2016 (subject to change). Ursa would like to leave the 24 conductors in place to support our drilling schedule. The 16" conductor pipe was set on 01/27/16 at a depth of 60' with 100 sacks of cement.
