## COMMENTS:

Status update for REM #9285: Pit remediation on the Hill 6-6 reserve pit began in the fall of 2015. Winter moved in before the work could be completed. With the late fall and early winter moisture the sites turned into mud and then froze. The Hill 6-6 is complete in regard to hydrocarbon removal and mostly backfilled. Whiting anticipates starting up again in April 2016 after the spring thaw and dry out. Work before then would not be practical as the ground in the area is currently frozen and when it first thaws the sites get very muddy. Work to date was completed in accordance with the approved course of action and discussions with the jurisdictional agencies.
