Post-remediation follow-up inspection for pit closures under REM #7592. Pit remediation was completed during January 2014 however NOC was received via F-4 February 2016. At time of site visit, temperature was 37 F with ~50% snow cover. All pits have been backfilled and re-graded. Signs indicate reclamation areas and prohibit vehicle traffic in those areas. Reclaimed areas are vegetated. Other locality inspections postponed due to extremely muddy and slushy road conditions.
