Comment: Stormwater erosion is occurring in the eastern, northern, and western portions of the project area. In places, stormwater is tunnelling through the eastern edge of the working area and gulying down the fill slopes. Erosion from the well pad appears to be carrying sediment toward the irrigation canal east of the project area. See attached photos.

CA: Stormwater erosion needs to be controlled within the project area. BMPs are needed to stabilize and de-energize stormwater flows in the western, northern, and eastern portions of the interim reclamation area.
