All,

It was nice meeting all of you yesterday. Your presentation and open forum afterward were very helpful and we hope you will continue having these small operator meetings on a regular basis. The break out session is very helpful for addressing specific issues.

As we discussed, I am sending this email listing the cleanup efforts we have made to date on the Afton/Alicia Pad. We will follow up with the submission of the Form 4 stating these corrective actions and to request an extension on the remaining items to be resolved.

The roads and pads have been bladed to eliminate the rutting. Waddling has been replaced. The locations have been seeded. The weeds have been cut down. The well signs are on order.

The two remaining items are to create the fenced storage yard (preferably on the western edge of the Afton pad) for our unused equipment, which we are presently working with the land owner to achieve, and secondly, to reclaim the unused portions of the pads. Also, Suncor and Schneider Energy have agreed to assist us in these efforts.

We appreciate your willingness to work with us so we can get in compliance with COGCC regulations.
