In addition, we are requesting that all stormwater BMP and erosion control action items to be extended to March 16, 2016 and the reclamation plan action dates to be extended to March 31, 2016. 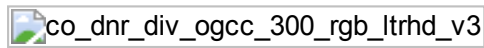
