This COGCC Form 4 is being submitted as a request to meet the background concentration levels for arsenic at the SG 23-32 well pad in accordance with footnote 1 to the COGCC table 910-1. The request is based on the analytical results presented below (see attached laboratory reports).

One composite sample was collected from the cuttings trench to determine the arsenic concentration in the cuttings.

SG 23-32 cuttings – 10 mg/kg

Five grab samples were collected from nearby non-impacted, native soil to establish the background arsenic concentrations.

SG 23-32-B-1 – 9.3 mg/kg

SG 23-32-B-2 – 10 mg/kg

SG 23-32-B-3 – 9.3 mg/kg

SG 23-32-B-4 – 9.6 mg/kg

SG 23-32-B-5 – 5.9 mg/kg

WPX Energy is requesting this approval in order to proceed with closure and reclamation of the SG 23-32 cuttings trench.
