Proposed Procedure:

1. MIRU RU pulling unit. Attempt to recover fish. If fish cannot be recovered, plug well as follows:
2. RU wireline company. TIH with CIBP. Set BP at 5480'. Top with 2 sxs 15.8#/gal CI G cement.
3. TIH with casing cutter. Cut 3 1/2" casing at 760'. Recover 3 1/2" casing.
4. TIH with tubing to 810'. Mix and pump 320 sxs of 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
5. Cut surface casing 6' below ground level and weld on cap.
