This is a Final Reclamation Inspection, a follow up to Insp Doc#680100443 as Snow Cover prevented ascertaining that there was no indication or Marker for Well. PA Well API# 045-05065 has Drilling report filed 11/29/60, completion date of 5/26/60 and Sundry filed of Plugging and Abandonment 8/8/1968. A COGCC 1962-63 review of Carter&Carter Wells in the Rulison Field has the Juhan #1 listed in one Category as Drilled and another Category as Abandoned-No work done. Location appears to have been scraped and construction at least begun when on site and Google Earth. Aerial pictures do not go back far enough historically to be sure disturbance is attributable to the Oil & Gas activities.
