The additional VOC's will handle the emissions from off-cycle production periods, while eliminating the visual and audible inconveniences that are often attributed to flaring operations. There will be no additional surface disturbance to accommodate the additional Combustors (please find the attached Scaled Facility Drawing for reference).
