Comments:

Marathon has completed interim reclamation at pad 596-32C. The drill cuttings from 596-32C were added to the reserve pit at 596-33C, at which point the cuttings were considered 596-33C pit material. Work began 6/02/11 and concluded on 6/04/11. Marathon's 596-32C well pad currently utilizes an evaporation pond, that was originally the location of the cuttings reserve pit. This site will be reclaimed during the closure of the evaporation pond. Portions of the excavated pad not needed for daily production activities were hydro-seeded and hydro-mulched beginning 10/20/11 and concluded 10/21/11. Approximately 2,676 cubic yards was moved. Remaining pad area is 155,748 sq.ft., 3.575 acres. Photos of revegetation were taken 5/20/14 and are included in attached reclamation report. Attachments include InterTech report, revegetation photos and asbuilts. Asbuilts include before and after interim reclamation drawings and stormwater flow. Page 2 of asbuilts incorrectly labeled the evaporation pond as "cuttings pit."
