Portions of the recontoured pad not needed for daily production activities was hydro-seeded and hydro-mulched beginning 10/31/11 and concluded 11/01/11. Photos of revegetation were taken 5/21/14 and are attached. 697-11X production pad contains 2 producing gas wells. Attachments include revegetation photos, pad asbuilt and stormwater flow map.
