Shoot 2 squeeze holes at 3782'.
RIH with composite cement retainer and set at 3700'.
RIH with tubing and stab into cement retainer.
Establish circulation with freshwater, leaving the bradenhead valve open.
Pump 350 sxs of 17.0 ppg cement and stage last two bbl of slurry to achieve squeeze with bradenhead valve closed.
Reverse circulate out any remaining cement in the tubing.
POOH with tubing.
Drill out cement, retainers, and solid plug.
Run CBL over squeeze.
Upon successful test continue with completions as planned.
