Comments:

Marathon has completed interim reclamation on this pad that included soil sampling, reserve pit closure, excavation, pad size reduction, re-contouring, and seeding. Pad work began 6/27/11 and concluded on 7/20/11. Hydro-seeding and hydro-mulching work was concluded on 5/18/12 for portions of the recontoured pad not needed for daily production activities. Pad has 3 producing gas well. Approximately 6,327 cubic yards was moved. Remaining pad area is 134,656 sq.ft., 3.09 acres. Photos of revegetation were taken 5/21/14 and are included in attached reclamation report. Attachments include InterTech report, revegetation photos and asbuilts. Asbuilts include before and after interim reclamation drawings and stormwater flow.
