Comments:

Marathon has completed interim reclamation on this pad that included soil sampling, reserve pit closure, excavation, pad size reduction, re-contouring, and seeding. Sundry with InterTech interim reclamation summary for pit closure and pad reduction was filed in document no. 400509579 approved 4/24/14. Portions of the recontoured pad not needed for daily production activities were hydro-seeded and hydro-mulched from 10/20/11 to 11/01/11. Approximately 8,696 cubic yards was moved. Remaining pad area is 136,964 sq.ft., 3.144 acres. Photos of revegetation were taken 5/21/14 and are included in attached reclamation report. Attachments include revegetation photos, interim reclamation asbuilt and stormwater flow map.
