Pad interim reclamation was started by the previous operator prior to operator transfer in August 2007. Marathon has completed revegetation work on this pad. Portions of the recontoured pad not needed for daily production activities was hydro-seeded and hydro-mulched beginning 10/31/11 and concluded 11/01/11. Photos of revegetation were taken 5/21/14 and are attached. 697-11X production pad contains 2 producing gas wells. Attachments include revegetation photos, pad asbuilt and stormwater flow map.
