


Petroleum Field Services, LLC has determined the surface location of the RATTLESNAKE FEDERAL LC10-770 to be 400' from the NORTH line and 1274' from the WEST line as measured at right angles from the section line of Section 22, Township 9 North, Range 59 West of the Sixth Principal Meridian, County of WELD, State of Colorado, and the bottom hole to be 330' from the NORTH line and 1045' from the WEST line as measured at right angles from the section line of Section 10, Township 9 North, Range 59 West of the Sixth Principal Meridian, County of WELD, State of Colorado.
