We would like to transport remediated soil from the western half of the landfarm associated with the historical release (Spill/Release Point ID 442534) at the Nolte 14-43d pad location (COGCC Facility ID 324087) to use as backfill/bedding material at our ongoing excavation associated with the High Mesa Waterline Release (Spill/Release Point ID 445122). Laboratory analytical results indicate that the soil from the western half of the landfarm complies with COGCC Table 910-1 Concentration Levels or within background concentrations, except for the EC and SAR measurements. However, this soil will be used to backfill the portion of the excavation that is deeper than three feet below ground surface. Laboratory analytical reports are attached to this form.
