## COMMENTS:

Per Condition of Approval 2 on the Form 4 Waste Management Plan (WMP) identified by COGCC Document ID 401018049, this Form 4 is being submitted with the intention of providing an update of landfarming activities associated with the release identified by Spill/Release Point ID 442534 at the Nolte 14-43d pad location. Two soil samples were collected from the landfarm on 10/5/2015 and submitted for laboratory analysis of all COGCC Table 910-1 analytes. Laboratory analytical results indicated that both samples had electrical conductivity (EC), sodium adsorption ratio (SAR), and total petroleum hydrocarbon (TPH) measurements that exceeded COGCC Table 910-1 Concentration Levels. The soil was then stirred/agitated and also allowed to naturally attenuate. On 2/22/2016, additional samples were collected from the landfarm and submitted for laboratory analysis of EC, SAR, and TPH. Laboratory analytical results indicated that both samples had EC and SAR measurements that exceeded COGCC Table 910-1 Concentration Levels. The TPH measurement of soil sample Nolte East also exceeded the COGCC 910-1 Concentration Level. A table summarizing the analytical data as well as the laboratory analytical reports are attached to this form.
