Noble respectfully requests to sundry COGCC Location ID 433076 (Rohn State LD03-65-1HN Multi) to consolidate facility equipment, add flowlines, and allocate new production to this existing production facility/well pad site. The new production from the Reagan, Nugent, Heston wells, will utilize the existing equipment at the location referenced. No new disturbance will be needed for this project.

- This location will now be set up to produce a total of 30 wells. Noble has previously abandoned the Rohn State LD03-67-1HN that was originally scheduled to produce at this location.
- The Reagan, Nugent, and Heston wells were originally set up and permitted to produce at the Nugent LD06-665 Multi (COGCC location ID 440366). This location was originally set up as a well/facility site. The facility portion of this Form 2A will not be constructed at this time.
