Proper testing was performed prior to backfill, with results below Table 910-1 values. We apologize for the delay submitting these results to the Commission.

Also - REM #7933 was opened by Whiting to review pit closure compliance in the Sulphur Creek field. The four pits requiring remediation have now been completed (8579, 8580, 8581, & 8583) and the original remediation project (7933) should be closed.

Environmental	Based on review of information presented, it appears that no further action is necessary at this time, and COGCC approves the closure request. However, should future conditions at the site indicate contaminant concentrations in soils exceeding COGCC standards or if ground water is found to be significantly impacted, then further investigation and/or remediation activities may be required at the site. Materials with pH, SAR, or EC concentrations exceeding Table 910-1 levels may be buried under a minimum of three (3) feet of backfill cover and soil that satisfies either the Table 910-1 levels for pH, SAR, and EC or the background levels for such contaminants within three (3) feet of the ground surface at the site.
