On February 12, 2016, historical hydrocarbon impacts were discovered along a produced water sump dumpline during construction activities at the HSR-Grant Brothers 10-31 production facility. Excavation activities are on-going and are being guided in the field by screening soil for volatile organic compound (VOC) concentrations using a photoionization detector (PID). Confirmation soil samples will be collected from the final extent of the excavation area. Site investigation and excavation activities will be summarized in a subsequent Supplemental Form 19.
