MIKE LEONARD, FIELD INSPECTOR FOR THE COLORADO OIL AND GAS CONSERVATION DIVISION, CAME ACROSS THE LOCATION OF THE SUBJECT WELL. THE RUTH O. PAIGE 1 WAS DRILLED AND ABANDONED BY BRIDWELL OIL COMPANY IN 1959, AND APPARENTLY NO LEVELING AND/OR RECLAMATION OF THE LOCATION WAS EVER PERFORMED. BRIDWELL OIL COMPANY CONTACTED BJ RANCHES, THE CURRENT OWNER OF THE LAND, DESCRIBED THE SITUATION, AND OFFERED TO RECLAIM THE SITE ACCORDING TO THE STANDARDS OF THE OIL AND GAS CONSERVATION DIVISION. A REPRESENTATIVE OF THE RANCH CONTACTED BRIDWELL AND REQUESTED THAT THE SITE NOT BE DISTURBED. BJ RANCHES HAS INDICATED THAT THE LAND UPON WHICH THE SITE IS LOCATED IS CURRENTLY IN USE, AND THAT LEAVING THE SITE UNDISTURBED WILL CAUSE NO HARM TO THE ENVIRONMENT, OR TO THE HEALTH AND SAFETY OF THE OCCUPANTS OR WILDLIFE. THEREFORE, BRIDWELL OIL COMPANY RESPECTFULLY REQUESTS THAT THE COLORADO OIL AND GAS CONSERVATION DIVISION DESIGNATE THIS MATTER AS RESOLVED.
