Comments:

The area reclaimed on the well pad was seeded with Dahurian Wildrye, VNS (24.49%), Intermediate Wheatgrass, Rush (19.03%), Orchardgrass, Profile (18.97%), Forage per. Ryegrass, Albion (18.74 %), Smooth Brome, VNS (14.07%) Switchgrass, Dacotah (19.89%), Thickspike Wheatgrass Critana (19.78%), Western Wheatgrass, Arriba (14.73%), Big Bluestem, KAW (13.04%), Annual Ryegrass, Gulf (9.99%), Sideoats Grama, Native (9.68%), and Little Bluestem, Camper (7.59%). A vegetation survey was conducted at the site on June 16, 2014. The Kerr-McGee Oil and Gas Onshore LP (Kerr-McGee) survey method consisted of randomly selecting 20 survey points on the well pad and 20 survey points within a reference area representative of the pre-disturbance vegetative levels. A Daubenmire frame was placed at each random survey point and a percent cover analysis was performed on the vegetation (excluding noxious weeds) within the frame. The vegetation survey for the reference area resulted in an average vegetation cover of 22%. The vegetation survey for the reclaimed well pad area resulted in an average vegetation cover of 18.25%. The vegetation survey data indicates that the well pad vegetation cover is 83% of the pre-disturbance/reference area vegetation growth, which surpasses the required 80%. Based on the Kerr-McGee survey method, interim reclamation as defined in regulation 1003.e. (2) has been met at the above referenced location. Four photographs were taken facing each cardinal direction. A fifth photograph was taken to document the total cover of live perennial vegetation of the site. A sixth photograph was taken to document the representative vegetation cover of the adjacent or nearby undisturbed land. A copy of the vegetation survey is attached.
