This sundry is meant to replace the previously submitted sundry from October 2014. It appears the sundry was lost in the COGCC submittal system.

Verbiage from the previous sundry submittal:

Bonanza requests approval to treat water-based bentonitic drill cuttings on the well pad and incorporate the treated cuttings into reclaimed soils as a beneficial amendment and for other beneficial re-use such as berm and road maintenance. The Onsite Reclamation E&P Waste Management Plan is attached. Written surface owner approval (BLM) has already been obtained.

The cuttings associated with the request above have already been remediated and are currently stockpiled onsite waiting on interim reclamation. Compliant analytical results for the remediated cuttings are attached to this submittal. Bonanza has also attached the WMP used to conduct the cuttings treatment and incorporation at the location.
