Battery equipment has not been removed. Production tree has been removed and flowline disconnected from wellhead. The well is closed to the atmosphere by a nipple, a collar, and a tap bull plug with a needle valve downstream of the master valve. Plugs set in well for offset frac. Well is remaining TA'd as it is uneconomic to return to production. Plan is to remove plugs and return well to production once commodity prices improve.
