This Inspection Report documents COGCC site visit with Talon LPE during excavation activities conducted as part of Remediation Project #9101. No other equipment was inspected during this site visit. The Satisfactory Status pertains to the Remediation Project #9101. A large area had been excavated to 10 feet depth with a deeper area excavated to 25+ feet to expose groundwater in the southwest corner of the excavation. The Operator was recovering water and free phase hydrocarbons from the deeper excavation. COGCC Staff and Talon personnel reviewed the excavation progress and discussed confirmation soil sample locations. Additional excavation is pending to the north and east areas of the excavation.
