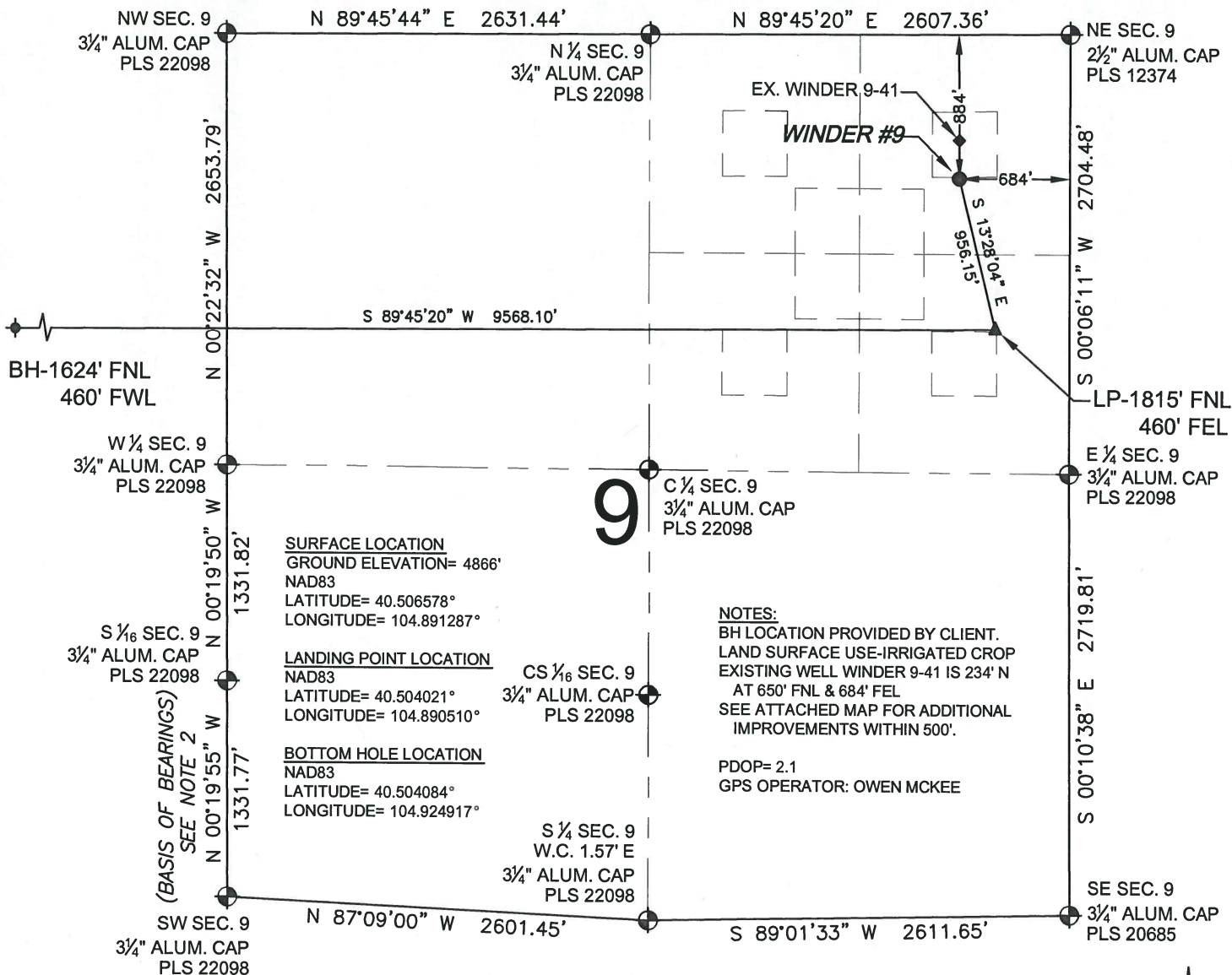


# WELL LOCATION CERTIFICATE: WINDER #9

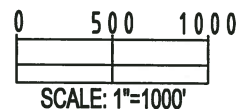

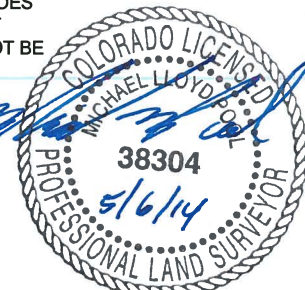

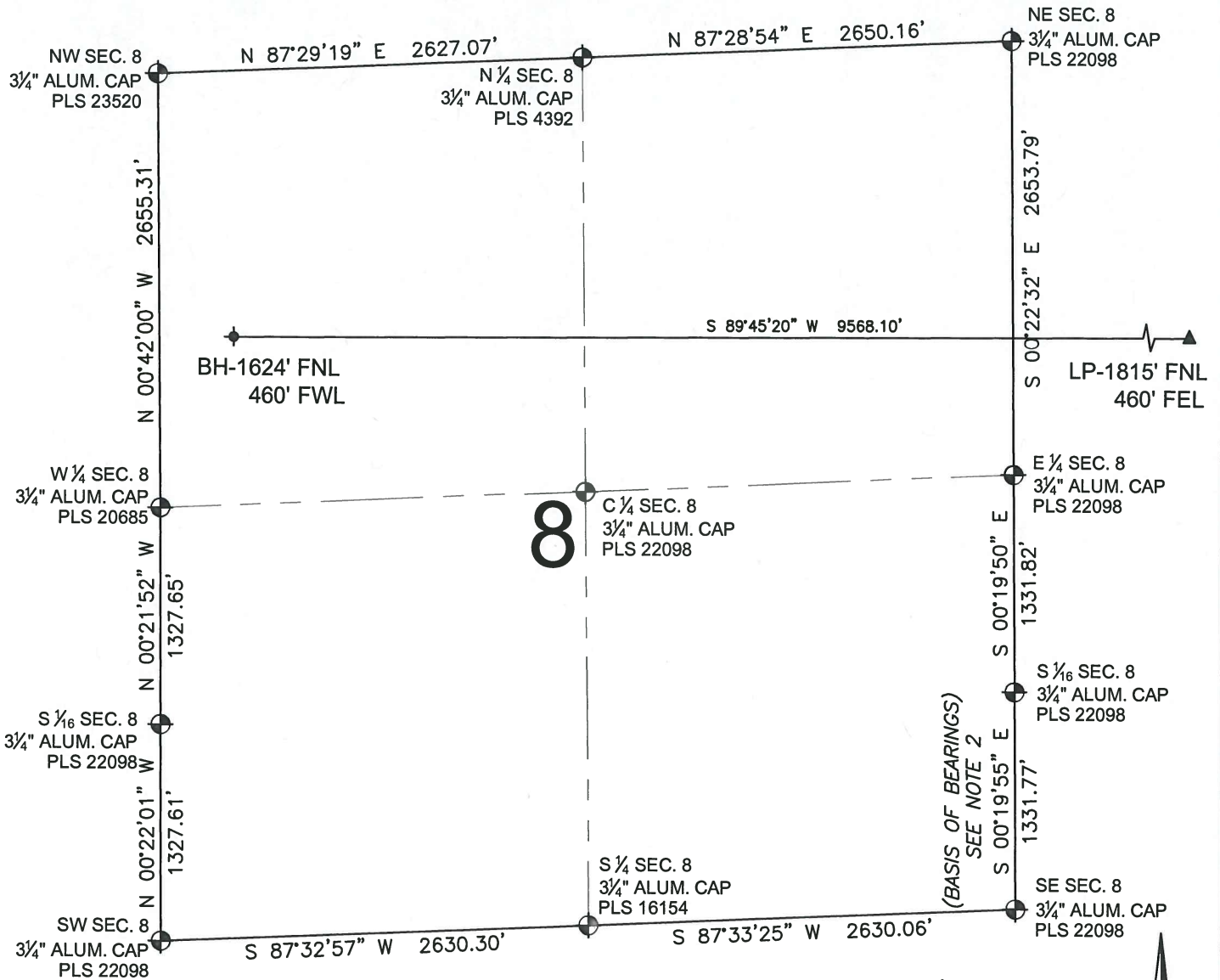
