Requesting an exception to ground water sampling requirements per statewide Rule 609.c. There is one permitted water source shown on the COGCC GIS Online interactive map within 1/2 mile of the proposed oil and gas wells, Colorado Division of Water Resources well permit number 38255. This well is a stock well on property owned by Jackie Fiscus. AGW spoke to Mr. Fiscus on December 22, 2015, and Mr. Fiscus confirmed that the well has been abandoned for approximately 8 years and is not available for sampling. There are no water sources located within one-half (1/2) mile of the proposed oil and gas wells.
