The Location has had signage changed to indicate Foundation ownership. Two pits on location. One (11945) pit at west side at separator ~150'x15'x5'deep within dirt berms. Pit is fenced and netted at ground level. No pw tank from separator at pit, however there is 95 bbl pw steel tank at pumpjack. Tank is at grade in dirt SPCC. There is small vacant tank pad at grade adjacent to pit. ~2 inches clear fluid visible in pit. No sheen or petroleum odor. No other indications of a release from wellhead, separator, or around pit such as staining, odor, free liquids or stressed vegetation. Seond pit (11946) is on east side of pad adjacent to arroyo. Pit is ~15'x15'x5' unlined dirt. Pit is fenced and netted and appears to be maintained. No apparent connection-F-15 stated "not in use"Second pit
