This sundry is being submitted to revise the BHL. There have been no changes to the surface hole location, the target formation, mineral lease or proposed well pad disturbance. The BHL, top of production zone, target formation (Niobrara), TD, offset well evaluation, casing and cement program and proposed spacing unit have been updated.

The New Proposed Spacing Unit is E/2W/4 & W/2E/2.

The distance to nearest well belonging to another operator is 496' measured to the P&A'd Gilmore 1-30 as shown on the anti-collision report. The distance to nearest well in same formation was measured to the proposed Johnson 01N-65W-30-9C located on the same well pad.
