## COMMENTS:

Caerus would like to use the remaining remediated soil associated with the release identified by COGCC Spill/Release Point ID 442525 to improve stormwater drainage on North Parachute Creek Road. This release has been officially closed via a COGCC-approved Form 19 (Attached to this document). Analytical results from samples collected from the removed soil indicate both soil samples were in compliance with COGCC Table 910-1 Concentration Levels for all analytes or were within background concentrations except for the electrical conductivity measurements. However, pending COGCC approval, this soil will be used as beneficial reuse to improve stormwater drainage on North Parachute Creek Road and will not be re-vegetated for many years. Specifically, the remediated soil will be used to raise the elevation of the road surface along areas of the road where stormwater runoff accumulates instead of draining. This will allow runoff to be conveyed to existing stormwater best management practices such as sediment traps and culverts. All remediated soil applied to the road surface will be covered with road base. Background samples were collected from an undisturbed area near the Chevron 41-8D pad (COGCC Location ID 324196).
