Well was originally shut-in for Horizontal Safety Prep with a RBP with Sand Cap at 7,192' and a RBP at 6,480'. A mechanical integrity test was performed to ensure integrity of the casing on 05/04/16. The well will continue to be shut-in for the next 4 to 5 years waiting for an engineering review. T&A status provided via a down-hole plug and surface isolation provided via closed master valve.
